Subject:- **Fixation of speed limits in the State of J&K.**

Vide this Headquarters' order, issued under endorsement no. THQ/GB/6459-67 dated 20/09/2010, a committee was constituted to fix speed limits (of various types of motor vehicles) within the State of J&K.

The committee met on 07-10-2010 and the members (experts), after detailed deliberations/discussions unanimously decided to fix the following minimum and maximum speed limits.

This order shall come into effect w.e.f. **01/11/2010.**
